McKINNEY, John R. 23 Aug 1862
Private McKinney was age 18 when he entered service. He was captured 3 May 1864 near Snaggy Point on the Red River, Louisiana; mustered out 19 July 1865 at Camp Chase, Ohio.

There were also boarders and a domestic living there.

Hardesty's Historical and Geographical Encyclopedia [Wayne county Ohio version] page 495 Franklin Township section: John R. McKinney--bade adieu to Ohio for nearly three years in the fall of 1862, and entered on the experience of a life in the field and in the enemy's country. He enlisted at Wooster, 22 August, 1862, and at Camp Mansfield, October 14, 1862, was mustered into Company A, 120th Ohio Volunteer Infantry. The regiment went to the front in time to take part in the two movements on Vicksburg, that under Sherman, including the battles of Chickasaw Bayou and Arkansas Post, and that under Grant, in which, a part of the 2d brigade, 3d division, 13th army corps, the 120th had its share in the fighting, and won its laurel with the victory. In all these battles Mr. McKinney participated, and when the regiment was in Louisiana he was engaged in the battle of Richmond, then started with the regiment on the ill-fated Red River Campaign. He was among the many captured at Snaggy Point, and he was one of the few who, after 13 months in the prison stockade at Camp Ford, Texas, were alive and able to move to the place of exchange. His suffering in prison was like that elsewhere told in these pages [[see the History section](#)]; cold, starvation, and a cruel enemy all did their work. The exchange which released him was effected at the mouth of the Red river, and at New Orleans he took transport for St. Louis, from that city came to Columbus, and was there discharged from service, July 8, 1865. He was born in Washington county, Pennsylvania, November 12, 1843, the son of William and Jane (Ray) McKinney. He married in Ashland county, Ohio, June 2, 1870, Anna Christie, who was born in Butler county, Pennsylvania, July 16, 1846, and is the daughter of William and Elizabeth (Hall) Christie. Their children are four living, one deceased: William, born September 6, 1871; Fred S., February 1, 1873; Charles H., June 18, 1875; Jennie, August 13, 1878, died October 2, 1880; Laura, October 3, 1881. Mr. McKinney has a farm in Franklin township and is also engaged in the profession of attorney. He is a member of Given Post, No 133, G.A.R., at Wooster, and his post office address is Wooster.

J.R. McKinney Passes Away

Civil War Veteran Dies at Home on College Avenue on Sunday Afternoon

Another old soldier, a veteran of three years service in the Civil war, over a year of which was spent in a Rebel prison, answered the last roll call Sunday when John R. McKinney died at his home on College avenue, death coming at 8:30 p.m.

Mr. McKinney has been in poor health for several years, but up until the present winter he was always able to be around. Catarrhal jaundice however, gained the upper hand after a long fight, and for several days it was seen that he could not live long. Mr. McKinney was 65 years of age.

He was born in Washington county, PA., November 12, 1844,*[the birth year actually seems to be 1843]* and came to Wayne county with his parents in his youth. They settled on a farm in Sugarcreek township. John McKinney enlisted as a private in Judge Downing's company, the 120th Ohio Volunteer Infantry, in August, 1862, and for three years was in the service of his country. The last thirteen months of this service, he was in a Rebel prison at Camp Ford, Tyler, Texas, he having been taken prisoner at Snaggy Point on Red river at the time of the attack on boat in which the 120th regiment was going to the relief of General Banks. His term in prison was full of the horrors so often dedcribed, and so impossible to exaggerate.

Mr. McKinney took part in all of the engagements of Grant in the opening of the Mississippi and for some months before the fall of Vicksburg he was especially assigned to the Pioneer Corps and therefore was almost constantly in the front.

Comrades speak well of Mr. McKinney as a soldier. Only eighteen when he enlisted, he was bright and active, brave, and daring and, was always in command of a detail of soldiers.

After the war he returned to Wayne county and came to Wooster where he read law. He was elected Justice of the Peace of Wooster township which office he filled with his characteristic effectiveness. He practiced law in Wooster until the death of his father, who in the meantime had moved to a farm south of the city. Then he moved on the home farm, and remained there until about ten years ago, when he returned to the city. During recent years he has been one of the active and prominent members of Given Post, G.A.R., and was Post Commander for one term. He served as Adjutant of the Post under several Post Commanders, and for many years has been secretary of the regimental organization of the 120th O.V.I., all of which positions, he filled very capably. Mr. McKinney attended school at the Hayesville Academy [*Hayesville is in Ashland county*], and there he met Miss Anna Christy, who afterwards became his wife. They lived together happily for many years, the wife passing away six years ago. Mr. McKinney was a member of the United Presbyterian church. He is survived by four children, William McKinney, of Carlin, Nevada; Dr. Fred McKinney of Leetonia, O., Dr. Chas. McKinney, of Pittsburg, and Miss Laura McKinney, at home. Funeral Tuesday afternoon at 1:30 o'clock, services in charge of Rev. Heron.

Another Veteran Gone

J. R. McKinney, a civil war veteran died at his home in Wooster Sunday afternoon. Mr. McKinney was born in Pennsylvania, moving to what is know as the McDowell farm west of Dalton in 1844, where he resided till 18 years of age. In August 1862 he enlisted in the 120th O.V.I. for three years. After the war he took up his residence in Wooster. During his residence in Sugarcreek township [*Wayne county*] he taught a term at the West Moscow school. During his career as a soldier he spent nearly a year in rebel prison.

Mr. McKinney was a member of the United Presbyterian church. He is survived by four children, Wm. McKinney of Carlin, Nevada; Dr. Fred McKinney of Leetonia, O. Dr. Chas. McKinney of Pittsburg, and Miss Laura McKinney at home.

Funeral was held Tuesday afternoon services in charge of Rev. Heron.
