

## Company B, 120<sup>th</sup> OVI

GORRELL, Calvin\* 4 Aug 1862 GARRELL GARLE

Private Gorrell was 29 when he entered service. He died 23 Feb 1863 at Young's Point, Louisiana.

In the Roll of Honor in the back of the Official Roster: buried at Vicksburg, Mississippi.

Marriage: Nancy WILLIAMS, 26 Dec 1858 in Richland County OH

Death: 23 Feb 1863 at Young's Point, LA

Cemetery: Vicksburg National Cemetery, MS. [Not listed at Department of Veterans Affairs at Vicksburg. May be buried there as an unknown.]

Registers of Deaths of Volunteers, 1861-1865: Calvin GARLE, Private, Co B 120th OH Inf, died 23 Feb 1863 at Regimental Hospital. Cause: chronic diarrhoea.

Have not found in Burial Registers, Military Posts and National Cemeteries, 1862-1960.

Not on U.S. National Cemetery Interment Control Forms, 1928-1962.

Pension Index: Calvin GARRELL, Co B 120 OH Inf. Widow, Nancy GARRELL, applied 25 Jun 1864, Application 25824, Certificate 15151. Information found in widow's pension records: Calvin enrolled at Monroe, Richland Co OH. Died Youngs Point, LA, 23 Feb 1863, of chronic diarrhea. Typhoid fever on another page.

Marriage: 26 Dec 1858 at Richland Co OH. Child Alvasetta GARRELL who was 2 yrs old. Enrolled for military at Monroe, OH. William P. WILLIAMS and James M. FIRST of the same company testified about his death and causes.

Ancestral file at Family Search. Calvin GORRELL born 1835 [maybe Knox Co OH]. Father Joseph GORRELL. Mother Maria LAUDERBAUGH.

1850 Census, North Bloomfield Twp, Morrow Co OH, Dwelling 728, Family 738: Joseph GARRELL, age 35 PA, laborer; Elizabeth, age 31 PA; Calvin, age 15 OH; Rachel A, age 11 OH; Sarah J, age 5 OH; Lydia, age 4 OH; John W., age 2 OH.

Richland County Probate Records: Calvin GORRELL married Nancy WILLIAMS on 26 Dec 1858 in Richland County OH.

1860 Census Lucas, Monroe Township, Richland County OH: Calvin GARL age 25 OH, a laborer; Nancy age 23 OH; Sevilla M, age 4 or 9 months OH.

1890 Veterans Schedule: Mansfield, Richland Co OH: Line 29, House 137, Family 148: Mary SAMS, widow of Calvin GORRELLE, Pvt, Co C [incorrect] 120 could not answer the rest. Post Office, No 5, NE Diamond St. Remarks: discharged from hospital.
