

## Company C, 120<sup>th</sup> OVI

STEARNS, Alonzo M. 13 Aug 1862 Alonzo Merrill STEARNS  
Private Stearns was age 34 when he entered service. He was discharged 15 Apr 1863 at Memphis, Tennessee on a Surgeon's certificate of disability.

Pension Index: Alonzo M STEARNS, C 120th OH Inf, applied for invalid's pension on 23 Oct 1863, Application 34861, Certificate 211597. His widow, Mary A STEARNS, applied for pension 4 Aug 1891, Application 501256, Certificate 301186, filed in Missouri. This record card has the death date for Alonzo as 24 Mar 1889 at Tipton, MO.

1860 Census, Series M653 Roll 930, Green Twp, Ashland Co OH, page 279: Alonzo STEARN[S], age 33 OH, master carpenter; Mary, age 30 NY; Nepthas P [Is this Mathias?], age 3 OH; Mary STEARNS, age 70 VT.  
[Nepthas must be Mathias shown in the 1880 Census.]

1870 Census, Worthington Twp, Richland County, OH, page 406: Alonzo STEARNS, age 42 OH, carpenter; Mary, age 40 NY; Martha, age 23 WI; Minena, [male] [Is this Mathias?]age 9 OH; Roby [female], age 6 OH; Emma, age 2 OH. [Note from Ian: "Miran" is actually Myron N. Stearns, b. <1861> in Ohio, d. 29 Apr 1932 in Ventura, California."Roby" is undoubtedly Ruby. Martha, I think, is a niece, d/o Alonzo's brother Norman Lanson Stearns and wife Rebecca Smith.]

1880 Census, Perrysville, Green Twp, Ashland County, OH, page 25D: Alonzo STEARNS, age 53 OH, sawyer, father born MA, mother born VT; Mary A, wife, age 51 NY, parents born NY; Mathis U or Mathias H, son, age 23 WI, sawyer; Miran N, son, age 19 OH, working in saw mill; Roby, daughter, age 14 OH; Eugena?, daughter, age 11 OH; Eva? M, daughter, age 7 OH.

Alonzo M. Stearns and Mary A. Heath were married 13 Apr 1851 in Perrysville, Ashland County, Ohio (certified copy of marriage included in pension papers).

That Alonzo M. Stearns enlisted at Green Twp., [Ashland] Ohio, 13 Aug 1862 as a Private; mustered in at Camp Mansfield, Ohio (looks like Capt. C.M. Peale? - writing very tiny and quasi-illegible) 14 Oct 1862, in Co C, 120th OVI, Capt. John F. McKinley.

In November and December 1862 he is reported "in hospital" at Memphis, and "so borne until discharged for disability 15 Apr 1863." Another section indicates he was honorably discharged at Memphis, Tennessee 11 Apr 1863 on a certificate of disability (chronic dysentery), however the certificate says he was discharged on 15 Apr 1863 at Memphis.

According to the certificate of disability, Alonzo was born in Ashland County, Ohio, is 34 years of age, 5' 7 + 3/4" tall, dark 'complexion', hazel eyes, black hair, and was by occupation a carpenter when he enlisted.

That Alonzo M. Stearns died 21 Mar 1889 at Tipton, Moniteau County, Missouri.

Mary A. Stearns appeared before notary public on 07 Aug 1890, in Moniteau County, to say she is the widow of Alonzo M. Stearns, etc. There are no children under the age of 16 listed.

That Mary A. Stearns was last paid \$12 on 04 Oct 1912 and was dropped because of death 18 Dec 1912.
