

## Company E, 120<sup>th</sup> Ohio Volunteer Infantry

HARTMAN, Alexander A.\* 15 Aug 1862

Private Hartman was age 30 when he entered service. He died on 9 Sept 1863 at Bridgeport, Ohio.  
[Bridgeport is in Belmont county near Wheeling, WV.] No burial information given in the Roll of Honor.

1850 Census, Canaan Twp, Wayne Co OH, Dwelling 146, Family 146: Samuel HARTMAN, age 41 PA, farmer; Eve, age 36 PA; Alexander, age 19 OH; Laranja [female], age 17 OH; Elmira, age 15 OH; Hiram, age 13 OH; Ephraim, age 11 OH; Samuel, age 6 OH; Jasper, age 3 OH; Francis, [male], age --- OH. [Member of LDS at Family Search: Samuel T. HARTMAN married Marie Eve WONSETLAR on 2 Nov 1829 in Washington Co PA.]

Wayne County Probate Court record: Alexander A HARTMAN married Sarah ZUVER on 28 Aug 1853 in Wayne County OH.

1860 Census, Chester Twp, Wayne Co OH, page 305: Saml T. HARTMAN, age 51 PA, farmer; Eve, age 48 PA; Ephraim, age 20 OH; Samuel, age 16 OH; Jasper N, age 15 OH; Francis, age 9 OH; Franklin, age 7 OH.

1860 Census, Chester Twp, Wayne County, OH, page 305: Alexd HARTMAN, age 28 OH, sawyer; Sarah, age 29 OH; William A, age 4 OH; Eugene, age 2 OH.

Wayne County Probate Court record: Sarah HARTMAN married Robert CAMPBELL on 9 Jun 1864 in Wayne County OH.

1870 Census, South Haven Twp, Van Buren County, MI, page 542: Robert CAMPBELL, age 35 PA, lumberman; Sarah, age 38 PA; Eugene HARTMAN, age 12 OH; Levy??? [could be Lizzie] [female] HARTMAN, age 9 OH; Jennie CAMPBELL, age 3 MI.

1880 Census, Wooster, Wayne County OH, page 378: Robt. CAMPBELL, age 45 PA, patent wright man, parents born Ireland; Sarah, wife, age 49 PA, parents born PA; Lizzie HARTMAN, stepdaughter, age 20 OH father born OH; Jennie CAMPBELL, daughter, age 13 MI. [Note: It appears that both of Alexander's sons, William and Eugene, were living up in Michigan in 1880 in the same house. South Haven Twp, Van Buren Co, MI, page 586: Wm A. HARTMAN, age 25 OH, farmer, parents born PA; Eunice, wife, age 23 OH, father born VA, mother born OH; Eugene A, brother, age 23 OH, teacher, parents born PA. ]

???Brother's death record in Ohio: File # 12884, Ephraim D. HARTMAN died 9 Feb 1930 at Wooster, Wayne Co OH. Widower of Margaret HARTMAN. Retired minister. Born 21 Nov 1840. Father Samuel HARTMAN, born PA. Mother Mary WHONSETTLER, born PA. Burial Wooster Cem. Informant Roy M. HARTMAN, of Wooster OH.

Pension at fold3.com:

Alexander enrolled in the 120th at Chester Twp., Wayne Co OH.

Widow, Sarah A., and Alexander had been married 28 Aug 1853 by Andrew Klinge, minister of the Gospel. She was Miss Sarah ZUVER.

Widow got no pension. She remarried Mr. Robert CAMPBELL, 9 June 1864, by D. Ecker, in Wayne Co OH. Children of Alexander A. HARTMAN: William A, born 29 Sep 1855; Eugene A., born 5 Oct 1857; Lizzie L., born 19 July 1860. Guardian: Robert CAMPBELL Esq. Residence Wayne Co OH, Post Office Burbank. Alexander's widow married Robert Campbell on 9 Jun 1864. Samuel M CAMPBELL and John C CAMPBELL were witnesses on Robert's affidavit.

William S. Allen was the attending physician at the birth of Eugene HARTMAN on 5 Oct 1857 at Cedar Valley [is in Chester Twp, Wayne, OH].

F. A. Warring was the attending physician at the birth of William Alfred HARTMAN on 29 Sep 1855 at West Salem, Wayne Co OH.

A. S. Sampsel was the attending physician at the birth of Luella HARTMAN on 19 July 1860 at Cedar Valley, Wayne Co OH. [This must be Lizzie.]

Alexander died at Canaan Twp, Wayne Co, OH on 9 Sep 1863. Furlough for 30 days dated 14 Aug 1863 for chronic diarrhea. Captain Eason testified that Alexander was in good health until after the battle of Chickasaw Bluffs in Dec 1862, when from exposure he took sick and remained sick until his discharge in March 1863. Attending physician testified that Alexander came home sick and died 9 Sep 1863 of congestive chills and chronic diarrhea in about two weeks after his return. He was greatly emaciated when he arrived.

Physician Malancthon HOAG, resident of Lodi, Medina Co.

"..he was called as a conselling [sic] physician in the case of Alexander A. Hartman during this last illness of said Alexander A Hartman deceased a private in Co 'E' 120h Regt O.V.I. That said Hartman died at Bridgeport [former name of Burbank, Canaan Twp], Wayne Co Ohio on the 9th day of September A.D. 1863 of a complication of disease the most prominent features were congestive chills and chronic diarrhea contracted in the United States service having returned home from said service about two weeks previous to his death on sick furlough being very feeble and greatly emaciated when he arrived at home. Affiant lived with in four miles of said Hartman....."

Physician William S. Allen, resident of Bridgeport, Wayne Co OH, was also in attendance in Alexander's last illness.

Furlough paper, Millikens bend, 14 Aug 1863.: Permission to go to Canaan, Wayne Co OH from 14 Aug to 14 Sept 1863 at which time he was to rejoin his Regiment at Vicksburg. Alexander HARTMAN, age 30, 5'9", dark complexion, dark hair, was a farmer, born in OH, enlisted at Chester Twp on 13 Aug 1862.

1 Oct 1866 Daniel WHONSETLER, age 66, of Wayne Co OH, post office Wooster, to be guardian of the minor children. Witnessed by Philip WHONSETLER.
