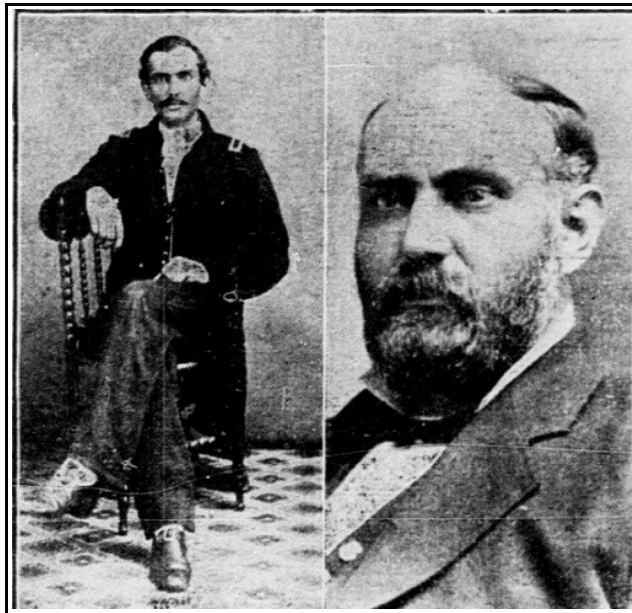
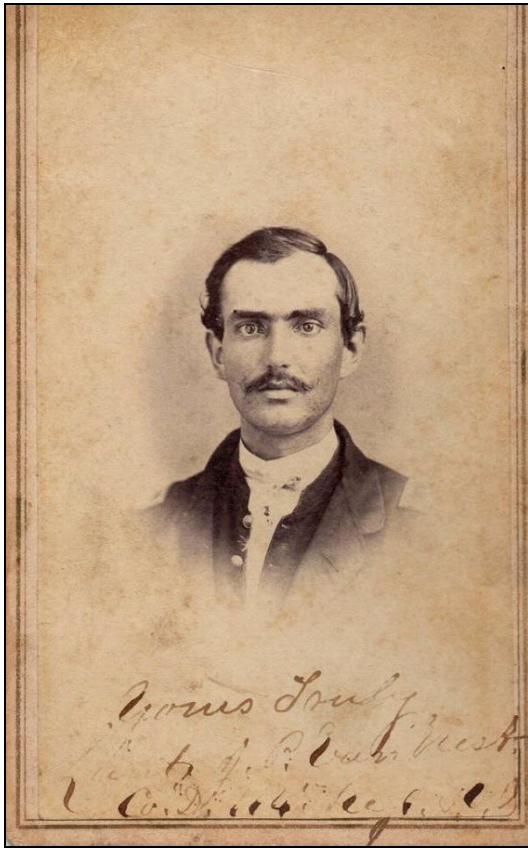


Company F, 120th Ohio Volunteer Infantry

1st Sergeant Joseph P. Vannest was age 21 when he entered service. He was appointed from private on 17 Apr 1863; transferred to Co. D, 114th OVI on 27 Nov 1864. Appointed to 1st Sergt from private April 17, 1863; transferred to Co. D, 114th OVI 27 Nov 1864. promoted to 2nd Lieut. 28 Dec 1864. Mustered out 29 June 1865 at Columbus, O by order of War Dept.

The National Tribune, 1 Sep 1887, page 4:

"Lieut. J. P. Van Nest, of Wooster, O., late of the 120th Ohio, celebrated his 46th birthday in an elaborate manner on Saturday, Aug. 6. A large number of his old comrades and their ladies were present. The presents were handsome. Serg't W. E. Montgomery, of Macon City, Mo., sent a large portrait of Col. M. M. Spiegel, which was elegantly framed. The Lieutenant also carries a very pretty gold-headed ebony cane, appropriately engraved, which was presented to him by his old comrades-in-arms present through Capt. J. B. Taylor. Letters of regret were received by Lieut. Van Nest from old army friends in Cleveland, Cincinnati, Mansfield, Ashland, Loudonville, Orrville, Richmond, Va., Indianapolis and Elkhart, Ind., Houston and Industry, Tex., Chicago, New York city, St. Louis, Washington city and other places. The supper, prepared by Mrs. Van Nest and daughters, Carrie and Gertie, was splendid, as were all the features of the celebration. In the evening a large number of young folks assembled and enjoyed themselves 'hugely.' It was long after midnight when the company reluctantly dispersed."

Cleveland Plain Dealer, Saturday, 31 Oct 1896, page 5:

"To the 120th Ohio Veterans. [from J. P. Van Nest]

Editor Plain Dealer--Sir: The Cincinnati Commercial Tribune contains a letter dated Port Townsend, Wa., Oct. 11, asking the publication of the following address:

'To the Survivors of the One Hundred and Twentieth Ohio Infantry Regiment: At Thompson's Hill, Miss., called sometimes the battle of Bayou Pierre, Gen. Osterhaus sent me to you with the following instructions, in substance:

' " ' Captain, the one Hundred and twentieth Ohio, a new regiment, is in bad shape at the front. The officers and men are experiencing their first battle. You go, take charge of it; put it in fighting trim, and when I come close enough to aid you strike the enemy hard, and tell the boys not to let my two Indiana regiments, which I will bring into battle, gain all the laurels.' "

'Do you remember the dusty looking cavalry captain who came to you on May 1, 1863, and what you did that day? Only one of you, Lieut. Buchwalter, late of Xenia, O., did I see after that battle, but I now send, from the new but important state of Washington, words of cheer and greeting to you all. I am getting too old to lead, but may I not request you, one and all (no straggling), to aid our comrade, William McKinley, in this struggle, fully as important as the one we were in at Thompson's Hill?

'Neither misfortune, want nor suffering can ever justify any of us in casting a ballot for the party of disorder, dishonor and repudiation. [McKinley was the Republican candidate] I would like to again impress the words of Gen. Osterhaus upon each man of this brave regiment: 'Do not let the Indianians gain all the laurels.' "

R.H. Ballinger 'Ex-Captain of Co. A, Third Illinois Cavalry.' [end of Ballinger letter]

I [J. P. Van Nest responds] am rather inclined to think that no such person exists as this 'ex-captain,' but if such person does exist I do not hesitate one moment in pronouncing his story untrue. Gen. Osterhaus and Col. Spiegel, who commanded the one Hundred and Twentieth O. V. I. at the battle of Thompson's Hill, were especially warm personal (German) friends, both able and experienced officers. Now, old veterans of the One Hundred and Twentieth, do you believe that Gen. Osterhaus would send this 'ex-captain' of the cavalry to supplant his especial and skilled friend, Col. Spiegel, and take from him his command in the face of the enemy on the field of battle? Never! And now, old veterans of the One Hundred and Twentieth, you who survive that terrible fight at Thompson's Hill on May 1, 1863, and were present upon that bloody field, as I was, do you not know full well that no such 'dusty looking cavalry captain' came near us on that day, or interfered with, in any way, the command of our commander, Col. Spiegel? You also know that no such word as that purporting to have been sent through this 'ex-captain' to the regiment by Gen. Osterhaus, 'that the officers and men of the One Hundred and Twentieth were experiencing their first battle,' etc, could have been sent, for Gen. Osterhaus himself commanded our regiment at the battle of Arkansas Post the 11th of January before, which was our second battle, and this battle at Thompson's Hill was our third? Our first battle was fought on the twenty-eighth and twenty-ninth days of December, 1862, at Chickasaw bluffs. So the 'ex-captain' falsified the record, not, perhaps, intentionally; nevertheless, his political masters directed him so to do.

For the much needed information of this 'ex-captain' and his political masters, in all charity, I inform him that in my humble judgment more than three-fourths of the surviving veterans of the One Hundred and Twentieth regiment, O.V.I., will cast their votes, without dictation of suggestion from any 'ex-captain' or McKinley political hireling, in accordance with our constitutional rights, for that grand, un-bought patriot and

statesman, William Jennings Bryan. [*Democrat candidate*]

"J. P. Van Nest was born at Rowsburg, Ohio, and upon taking up a business career entered upon that of insurance in which he was successful. In the spring of 1873 he removed to the city of Wooster, and here continued in the insurance business until his death, which occurred on April 3, 1905. Mr. Van Nest was a public spirited man and took a keen interest in public affairs, serving for two terms as a member of the Wooster city council. Early in the great Rebellion, Mr. Van Nest enlisted for service in the defense of his country's flag, joining the One Hundred and Twentieth Regiment of Ohio Volunteer Infantry, and served three years, taking part in battles were the following: Chickasaw Bayou, December 28-29, 1862; Arkansas Post, January 11, 1863; Thompson's Hill (Port Gibson), May 1, 1863; siege of Vicksburg, May 18 to July 4, 1863; Big Black River, May 17, 1863; Jackson Miss., July 9-16, 1863; transport "City Belle," near Snaggy Point, Louisiana, May 3, 1864. Mr. Van Nest enlisted as a private, but, by faithful and meritorious service, he retired from the service with the rank of second lieutenant. At the battle of Vicksburg he was severely wounded by a fragment of shell. Prior to entering the military service Mr. Van Nest had followed the trade of harness-maker, but on his return home he gave that up and took up the insurance business. He married Mary E. Gardner, who was a native of Lancaster county, Pennsylvania, as were also her parents. She is still living in Wooster, at the age of sixty-seven years. By her union with Mr. Van Nest she became the mother of the following children: John, of Wooster; M.M., the subject of this sketch; Carrie, the wife of William L. Derr, of Cleveland, Ohio; Gertrude, deceased; Maud M., the widow of John Griffith and living in Wooster: Ellen, deceased; Charles W., of Wooster; Mabel unmarried and remains at home."

Wayne County Democrat, page 6, 26 Apr 1905.....died 23 Apr 1905 [Summary]

The Funeral of Lieut. J. P. Van Nest was held Wednesday afternoon at the family residence on West Liberty street. It was largely attended by relatives, friends and citizens, old soldiers of his regiment, members of Given Post G. A. R. and associated bodies, members of Masonic fraternity and Wooster Commandery of Knights Templar.

The services were under the auspices of the Knights Templar. The singing was by Mrs. J. M. Minier, Miss Cora Hoelzel, Paul Stauffer, and Will Dramer. Rev. S.E. Neikirk, of the Reformed church, assisted by Rev. Dr. H. D. Stauffer [?Henry Stauffer, Co F], first conducted the church services, and then as acting Eminent, Commander, the Impressive ritualistic Templar service.

The tributes of flowers were many and unusually beautiful from relatives, friends and organizations among which were the special pieces from family, Knights Templar, Comrades of the 120th Regiment, Fraternal Order of Eagles, City officers and employees, Rathbone Sisters, Daughters of Veterans, John Baer [Co H] of Appleton, Wisconsin who was a comrade of the 120th, and the Tashmoo Club.

Pallbearers were S H Boyd [?Samuel Boyd Co. I], Geo. A Fisher, George J Schwartz, L R Kramer, David Nice, W I McGlenen. Honorary pallbearers were members of the 120th Regiment: Capt J B Taylor [Company H], Lieut. Mahlon Rouch [Company A and Field & Staff], John R. McKinney [Co A], Albert Smyser [Co D] of Wooster: Capt N Au of Mansfield; David E Foltz [Co A] of Shreve.

"At conclusion of the services a last sad view was taken of the familiar form lying at rest in the flower laden casket. The remains were then placed in the hearse by the acting pallbearers, Sir Knights S. H. Boyd, Geo. A. Fisher, George J. Schwartz, L. R. Kramer, David Nice, W. I. McGlenen; and the honorary pallbearers, all members of the 120th Regiment, O. V. I., Capt. J. B. Taylor, Lieut. Mahlon Rouch, John R. McKinney, Albert Smyser, of Wooster; Capt. N. Au, of Mansfield; David E. Foltz of Shreve. The large funeral procession then wended to the cemetery, where with sorrow and solemnity the body was committed to the grave; and he left there to rest where over him will bend the arching sky, as in other days it did in great love when he pitched his tent and lay down, weary and foot sore by the way, or on the battlefield for an hour's sleep."
