GARBER, Samuel 22 Aug 1862

Samuel, age 33, is listed in the Roster of Ohio Soldiers 1861-66 volume 8, page 261 as a private. He was transferred to Co. K 114th OVI on 27 Nov 1864. Transferred to Co E, 48th OVI, 24 July 1865. Mustered out 14 Oct 1865.

<p>Death of Samuel Garber.</p> <p>Mr. Samuel Garber was found dead in his home in the north-east part of Norman on Sunday afternoon last, his body lying across the threshold of the house. Physicians think he died from suffocation, caused by the rupture of an artery. Indications are that while lying on his couch taking an after-dinner nap, he was taken with a coughing spell, which ruptured an artery in his throat, and that he got up and staggered to the front door to spit out the blood. Several big splashes of blood between the couch and door show that he was not able to retain the blood which came up into his mouth, and when he got to the door he fell on his face and the blood smothered him. He was quite dead when found.</p>	<p>Mr. Garber was 82 years of age and an old soldier. He lived alone, but near his daughter, Mrs Lizzie Bennett, and his son; in the same yard. He ate dinner with his daughter, and appeared as well and jolly as usual. His funeral was held Monday afternoon from the house, services being conducted by Elder J. R. Carmack followed by ritualistic services of the G. A. R. at the grave in Odd Fellows' cemetery.</p> <p>Mr. Garver was one of Norman's highly respected citizens and his children have the sincere sympathy of the community. He had seven children living. Those present at the funeral were:</p> <p>Mrs. E. M. Adkins, of Duncan, I. T.; Mrs. Davis. Mrs. Bennett, and Mr. John Garber of this city.</p>

The happy couple are residents of this county and the many friends of the groom will be pleased to learn that he abandoned his bachelorhood idea and took unto himself a wife.

1895 Nov 27 – Married: Miss Minnie McKinney and Henry Garber were married last Saturday.

1896 May 22 – Whereas it appears from the evidence of Samuel Garber, Paul V. Adkins and A.W. Adkins that Henry Garber was erroneously assessed with 180 dollars in personal property tax for 1895.

1914 Oct 7 – Died: At the home of his daughter, Mrs. Minnie Garber, in the northeast part of Norman, at 9:30 pm Monday Oct 6, 1914, Mr. W.W. McKinney, aged 66 years. The funeral will be held from the residence at 4 o'clock this afternoon with internment in the IOOF cemetery.

1915 Feb 3 – Two fires No Damage – The alarm this morning was from away out in the northeast part of town; from Mr. Garber's home, 838 W. Third.

1917 July 26 – Mrs. Garber of Norman spent the weekend with her brother Mr. Sham McKinney and family.

1917 Dec 17 – in community Christmas Tree: Beulah Garber

1918 May 6 – Items made by students for Red Cross: Eighth grade: Mae Garber – One pair of wristlets.

1920 Apr 15 – INFANT SON DIES. Harry Jr., nine-months-old son of Mr. and Mrs. Harry Garber, died at the home of its parents at 109 West Gray street at 6 o'clock this morning. Funeral will be held tomorrow at 2 o'clock at Fairview cemetery, east of Maguire.

1920 Apr 18 – CARD OF THANKS. We desire to thank the friends who were so kind to us during the illness and death of our son and grandson and for the beautiful flowers. Mr. and Mrs. Harry Garber, Mr. and Mrs. John Garber, Mr. and Mrs. Newton Brown.

1920 Apr 29 – FOR SALE. A Reed baby buggy. Mrs. Harry Garber, 109 West Gray.

1921 Oct 27 – PERMITS ISSUED FOR THREE RESIDENCES – and to John Garber, a \$200 repair job, on South Steward.

1922 Jan 5 – Mr. Garber died at the home of his daughter Rosa in Norman, of pneumonia. Mr. Garber was well along in years. He leaves a wife, son and daughter and several grandchildren. He used to live southwest of Franklin several years ago. Burial was at Blackburn cemetery last Wednesday. Services were conducted by Rev. Havill of the Christian church of which Mr. Garber was a member. The sympathy of the community goes out to his wife and relatives in their bereavement.

1922 Jan 12 – Mr. Ray Barnard formerly of this community and Miss May Garber of Norman were married on Sunday January 1st.

1922 Aug 17 – Grandma Gill went to Norman Sunday night to visit her granddaughter, Mrs. Cora Garber for a few days.

Cromwell left Tuesday afternoon by automobile for Enid, where they will spend their Thanksgiving vacation.

1922 Dec 3 – GARRETT IS INJURED IN MOTOR ACCIDENT – Chester Garrett, employee of the G. & G. Cleaning company, is suffering from a mashed leg and a sprained ankle as the result of a collision between the delivery car and a car driven by Mrs. Minnie Garber of 422 North Steward avenue. Mrs. Garber was only slightly hurt.
