SCOTT, John H. 22 Aug 1862 John Hughes SCOTT

Private Scott was age 28 when he entered service. Discharged 1 Apr 1863 on a Surgeon's certificate of disability.

Father: William SCOTT

Mother: Rebecca HUGHES

Birth: 30 Apr 1835 [used date calculator]

Washington Co PA

Marriage: Minerva B. BROWN on 6 Nov 1863 in Van Wert Co, OH

Death: 25 July 1888 at Roland, IA,

Cemetery: Nevada Municipal Cemetery, Story Co IA

Died age 53 yrs, 2 mths, 25 dys

Soldiers and Sailors site also lists him as John C.

Pension Index: John H SCOTT of 120th OVI: Invalid filed 24 June 1880?, Application 399928, Certification 671125. Widow Minerva B SCOTT filed in Iowa on 5 Oct 1888, Application 381651, Certificate 310598, filed in IA. And a minor guardian [Minerva B RICHIE] was applied for in 1893 Oct 24, Application 585013, Certificate 392974, filed in OH. Pension Card: John died 25 July 1888.

1850 Census, Springfield, Richland Co OH, Dwelling 423, Family 423: William SCOTT, age 56 PA, farmer; Rebecca, age 41 PA; Margaret, age 18 PA; William, age 16 PA; John, age 15 PA; Caroline, age 13 OH; Alex, age 10 OH; Logan, age 7 OH; Samuel, age 4 OH; Gertrude, age 2 OH.

1860 Census, Springfield Twp, Richland Co OH, Dwelling 1364, Family 1374, page 99: Rebecca SCOTT, age 52 PA; John, age 25 PA, clerk D.G.; Logan, age 17 OH; Samuel, age 14 OH; Alice, age 11 OH. [Note parents: William SCOTT married Rebecca HUGHES 22 Sep 1830. Rebecca SCOTT died 28 Mar 1878 in Van Wert, OH.]

Van Wert County Probate Court record: John H SCOTT married Minerva B. BROWN on 6 Nov 1863 in Van Wert Co, OH.

1870 have not found.

1880 Census, Oak St, Nevada, Story County, Iowa, Dwelling 142, Family 144: Jno H SCOTT age 45 OH, laborer, parents born PA; Minerva B., wife, age 35 OH, parents born PA; Willie, son, age 14 OH; Lizzie M, dau, age 8 IL; Luta M, dau, age 5 IA; Maggie, dau, age 1 IA. [At Heritage Quest this one was listed as Jms. H SCOTT but it is clearly Jno which is an abbreviation for John or Jonathan.]
