*Ezra V. Dean was born in Wooster about seventy years ago. His father had been Judge of the Court of Common Pleas and had served in Congress two terms and gave the son a college education, who, when he was admitted to the bar in 1853, formed a partnership with his father. [Father Ezra died 25 Jan 1872 and is buried at Woodland Cemetery, Lawrence Co OH; mother Eliza died 11 July 1873 at Ironton, Lawrence Co. Ohio Marriages: Ezra DEAN married Eliza NAILER/MAILER on 7 Mar 1825 at Wayne co OH, Thomas Barr, Minister of the Gospel. ] This, to the son, was an auspicious introduction. He made advancements in his profession and acquired a reputable standing as a counselor and trial lawyer. He served in the Ohio Legislature from Wayne county, from 1854 to 1856. When the 120th O. V. I. was organized, he was appointed Quarter master, resigning in the fall of 1863. In 1865, with his family he removed to Ironton, Ohio, resuming the practice of law there, and where he at present lives.*

Pension Card: Ezra V. DEAN, Field and Staff 120th, Quarter Master. Invalid filed 29 Jan 1891. Widow applied 5 Feb 1916. Ezra died 12 Jan 1916 at Ironton, OH. Pension Index: Widow Charlotte A. DEAN applied in Ohio.

Wooster Republican, 15 Feb 1872, p2, father's obituary: "Upon his [the father's] retirement from Congress he resumed the more congenial pursuit of the practice of his profession in Wooster, and in the year 1852 took into partnership his son and only child, Ezra V. Dean, whom he had trained for the bar. This relation continued until 1865, when the son moved with his family to Ironton, Ohio, and engaged in an active practice there. The father could not endure a separation from his only son and his grandchildren. He at once resolved to set his affairs in order, and to spend the evening of his life with them on the banks of the Ohio; he accordingly moved to Ironton in the year 1867, where he made his home and found his grave."

Ezra's son, [James Theodore Dean](#), became a Brigadier General and fought in France with the 156<sup>th</sup> Infantry Brigade.
