Effects of Deceased Soldiers.

Mr. Weston Flint, Ohio Military Agent, gives notice that **unclaimed packages of effects of Ohio soldiers, who died in St. Louis hospitals, or on hospital steamers**, have been sent to Gen. D. W. Hay, Quartermaster-General of Ohio, and can be had by addressing that officer at Columbus:

Calhoun, Andrew, Nonpareil, Knox Co., Ohio.

Culvert, Asa S., 78th O. V. I., not known.

Dennis, Daniel, Mt. Sterling, O.

Edgill, Charles, Portsmouth, O.

Gnedy, David, Millersburg, Holmes Co., Ohio.

Letz, Absalom K., 796th O. V. I., not known.

Parker, L. L., Monroe, Ashtabula Co., Ohio.

Robertson, A., Perryville, Richland Co., Ohio.

Robinson, James A., Newville, Richland Co., O. [Note: James A. Robinson, Co H 120th OVI, died on hospital steamer "R. C. Wood"]

Stough, Mrs. Rebecca J., Blachleyville, Wayne Co., O. [Wife of William Stough]

Stough, W. H., Blachleyville, Wayne Co., O. [Note: William H. Stough, Co. E 120th OVI, died on hospital boat "Die Vernon."]

Shock, Miss D. J., Congress, Wayne Co., O.

Tripp, Calvin, K, 114th O. V. I., Fairfield, O.

Thompson, Henry, Plymouth, O.

Vincent, J. C., Idoway, Knox Co., O.

Wood, John A., Gallipolis, O.

Yode, Joseph R., 120th O. V. I., not known. [Note: Joseph R. Yoder, Co H, 120th OVI, died on board the "Von Phut." From Milton Twp, Wayne Co OH]

A number of soldiers of the 120th OVI were moved to National Cemeteries after the war after having been buried out in Louisiana and along the Mississippi. Not all were found or identified.

"The Graves of Union Soldiers. The War Department has just issued an order relative to

the graves of United States soldiers, as follows: All persons engaged in the cultivation of land who may have the graves of United States soldiers located upon their lands, are hereby forbidden to mutilate or obliterate the traces of such graves by ploughing or otherwise, or to disturb the headboards, stakes, or fences around them. All officers on duty as provost marshals, post commanders, or otherwise connected with the military service, are instructed to send information of the locality and condition of such graves and of any breach of this order, to the Quartermaster General."

Morfoot, Jacob murdered 8 Dec 1866. Morfoot is somewhat of a mystery. Captured at Snaggy Point but released. Did he desert after that? Widow was denied pension on his record.
